THIS YEAR, DUE TO COVID, OUR INTERNATIONAL PROGRAMING SHIFTED TO THE WESTERN UNITED STATES. OUR FALL COHORT OF 11 STUDENTS TRAVELED FROM MONTANA TO ARIZONA'S MEXICO-US BORDER. 10 SPRING SEMESTER STUDENTS REVERSED DIRECTIONS, BEGINNING IN THE DESERT SOUTHWEST AND CULMINATING THEIR EXPERIENTIAL LEARNING IN MT.
